Referred to Committee on Homeland Security and Government Affairs.

Bill to 1) restructure the current retiree health and pensions benefits payments 2) make permanent the current exigent rate increase 3) propose a pause in facility closings for two years for processing facilities and five years for retail post offices 4) implement stronger delivery standards 5) allow the Postal Service to introduce new non-postal products and services, and 6) increase the transparency of Postal Service delivery results.

H.R. 3464 Defending Quality Postal Delivery for the Future Act

S. 1854 Postal Innovation Act

Referred to Senate Committee on Homeland Security and Government Affairs.

Bill to allow authorization of new non-postal services. Bill also outlines a pilot program to assess implementation of providing non-postal services, provides guidelines for updating the fleet of the Postal Service, and outlines a plan for reinvesting cost savings from expanded services.

Bill to end the ban on shipping alcohol through the U.S. Mail.

S-1742 Rural Postal Act of 2015

Referred to Senate Committee on Homeland Security and Government Affairs.

This bill provides for a moratorium on closing or consolidating postal facilities for two years, provides for new considerations in determining whether to discontinue a rural post office, creates a Rural Postal Service Advisory Commission, creates a Chief Morale Officer for the Postal Service, reinstitutes stronger service standards, encourages the Postal Service to look into equipping delivery vehicles to handle landscape and severe weather challenges, preserves 6-day delivery, and includes a pilot program for implementing WiFi in rural post offices.

Also discusses adequate advance notice of closings to customers and for the USPS to provide alternative access after closing a post office.
